

**NOTICE OF HEARING ON SOUTH DAKOTA

The hearing is on the proposal for the Authority to issue an Agricultural Development Revenue Bond, for the Project identified below, in the maximum principal amount indicated. The proceeds of the Bond shall be loaned to the Borrower named below (who will be the owner and operator of the Project) for the purpose of financing a portion of the cost of the Project described below.

Livestock Nutrient Management Bond Project Number: 6-0040. Project: To assist in the construction of a livestock nutrient management system for a dairy operation. The Bond, when issued, will be a limited obligation of the Authority and will not constitute a general obligation or indebtedness of the State of South Dakota or any political subdivision thereof, and shall not be payable in any amount by taxation, but the Bond will be payable solely and only from amount received from the Borrower, named above under a Loan Agreement between the Authority and the Borrower, the obligation of which will be sufficient to pay the principal of, interest and redemption premium, if any, on the Bond as and when it shall become due.

Any individual affected by the above described Project may be heard, or may submit statements which will be publicly read at the scheduled time of the aforementioned local hearing on said Project. The aforementioned local hearing will be conducted in Clark county where the Project is located.

At the time and place fixed for the public hearing, all individuals who appear will be given an opportunity to express their views for or against the proposal to issue the Bond for the purpose of financing the Project, and all written comments previously filed with the South Dakota Economic Development Finance Authority, 711 East Wells Avenue, Pierre, SD 57501, will be considered.
