- Will be Repeated Next Year




# The 2023 Legislature

- Senate: 31(R) 4(D) = 35
- House: 63(R) 7(D) = 70
- 33 New No Previous Legislative Experience
  - 5 in Senate; 28 in House
- New Record number of Women = 31!
  - Senate 8
  - House 22

## **Vetoes**

- SB 129 Include school employees in certain assault provisions
- SB 108 "Sip N' Spit" exception taste a fermented beverage
- HB 1209 Provisions regarding industrial hemp

- HB 1109 Occupation tax for bus improvement districts.
- HB 1193 Uniform Commercial Code.

# Workforce Housing Done First Two Weeks (Passed 1/23; signed 2/01)

- \$200 Million (\$150 million state funds; \$50 million Fed)
  - Half Grants/Half Loans
  - Used for Infrastructure
  - 30/70 Split based on Population
  - Grants/Loans cannot exceed 1/3<sup>rd</sup> total infrastructure cost
- Appropriated to the Housing Development Authority
  - Creates a new fund
  - Price limited to first time homeowner program/Lot to \$40K
  - Document housing need with a market study

## "Infrastructure"

 "Public infrastructure," a right of way, water distribution system, sanitary sewer system, storm sewer system, lift station, street, road, bridge, curb, gutter, sidewalk, traffic signal, or streetlight, which is or will be owned, maintained, or provided by a political subdivision of this state; or excavation, compaction, or acquisition of land for such purposes.

# Budget

- \$60 M New Women's Prison
- \$52 M Design/land men's prison near S Falls
- \$70 M Upgrade accounting system
- \$30 M Construction inflation projects

- 7% Increase K-12 & Technical Colleges
- 7% Increase in state employee salaries
- 5%+ Increase in Medicaid providers Plus

## **Tax Breaks**

#### Governor – Groceries Out of Sales Tax

- Not based on fairness; based to give back
- \$100+ million permanent reduction in Revenue

### Property Tax Reduction

- \$100K Reduction in taxable value
- \$325 Credit to pay property taxes
- \$425 Check to Homeowners

#### Rate Reduction – 4.5% to 4.2% – All In

Repeal Partridge Amendment; Sunset

# **Chamber Analysis**

- Property Tax
  - Not workable



- Voting for tax break biggest break to target
- Everyone buying groceries All families
- Rate Reduction
  - Voting best tax policy kept broad base
  - Business gets reduction



## **And The Winner Is:**

## Rate Reduction –

- State sales tax rate is reduced: 4.5% to 4.2%
  - Small reduction \$100 purchase = 30 cents
- All taxpayers
  - Including Chamber members
- Sunset 2027 Legislative Session
  - First session for the next Governor
  - Tax increase without a vote
  - Could be extended



# Property Tax Limits Mil Levy Reductions Every Year

## City & Counties Limited Revenue

- 3% or Inflation; whichever is lower
- Plus growth new properties
- Revenue divided by tax base = Lower mil levy

#### School Taxes

- General Fund Levy Set by the State
- State-Aid Formula

# School General Fund Levies 3% Lower for 2024

### Agriculture Land

- From \$1.362 to 1.320 per \$1K
- Taxes on \$500K acres \$681 to \$660 (-\$21)

#### Homeowners

- From \$3.048 to 2.954 per \$1K
- Taxes on \$500K \$1,524 to \$1,477 (-\$47)

#### Commercial

- From \$6.308 to 6.113 per \$1K
- Taxes on \$500K \$3,154 to \$3,056 (-\$98)

# Reemployment Assistance HB 1011 Unemployment Insurance

- Federal program with shared costs
- State trust fund has \$180+ million
  - Governor Noem used Covid funds to replace fund
- HB 1011 creates a third fee schedule
  - Max rate = 9.3% (\$1,395) to 8.8% (\$1,320)
  - Base of \$15,000
- Surcharge Sooner less harsh
  - Payments get credited to business accounts

# **Economic Development Organizations**Property Tax Exemption

- Increase from \$750K to \$2.5 Million
  - Inflation is worse than anyone realizes
  - More realistic level purpose of the organizations

- No Loss of Revenue City/County/Schools
  - Schools Increase in state-aid
  - City/County Tax shift

# **Shifty Business**

### Pennington County – 12.6 Billion Tax Base

- County Mil Levy = 4.771/1K
- Exemption of \$2.5 million = \$11,928 shifted
- Increase to Taxpayers < 0.00009 mil</li>
- Increase to \$500K = half of a penny

### Brule County (Chamberlain) - \$1.1 Billion

- County Mil Levy = 4.51/1K
- Exemption of \$2.5 million = \$11,275
- Increase to taxpayers < 0.001 mil</li>
- Increase to \$500K = 50 cents



## **Eminent Domain**

### CO2 Pipelines

- Need to sequester CO2
- Critical to the Ethanol Industry
- 8 bills control access; limit eminent domain

#### Two Survived the House

- HB 1033 CO2 pipelines NOT common carrier
- HB 1230 Clarify condemnation court action

#### Both failed in Senate Committee

Proponents displayed grace

# **Paid Family Leave**

### Governor Expanded Leave for State Workers

- Was 6 weeks at 60% pay
- Governor moved to 12 weeks at full pay

#### Governor Wanted to Facilitate Private Sector

- HB 1151 create paid family leave program.
- Private insurance plan available to business
- Reduce cost of offering paid leave
- Deferred to 41<sup>st</sup> day by Appropriation Committee
- SB 154 \$20 million underwrite policy failed

## **Foreign Threats**

- Purchase of Agricultural Land
  - SB 185 Committee to review purchases
  - No purchase by foreign entity or person
  - 180 days review extend 180 more days

- SB 189 prohibit contracting companies owned by certain foreign entities or gov't.
- China, Cuba, Iran, Russia, N Korea, Bolivia, Venezuela

- HB 1117 SD Manufacturing and Technology Solutions
  - Lake Area Technical Collage
  - Department of Education
- HB 1118 Small Business Devel Centers & APEX (Procurement Tech Assist)
  - Board of Regents

# **Noteworthy**

- HB 1055 Increase Opportunity Scholarships
- HB 1056 Increase Terms for Bd Tech Ed
- SB 149 Saving Medicaid Bonus Funds
  - \$50 million each for two years
  - Pre-Paid for FY 25 budget
- HB 1208 Govt not contract with Bus ESG
